
Dear Resident:

I am writing to inform you that the Comsewogue School District, **pending passage of the New York State budget**, will continue the Universal Pre-K program for district residents. The program will be a half-day program beginning in September and will extend for the duration of the school year. Parents must provide their own transportation. We will be partnering with ***SCOPE Education Services***. The Universal Pre-K location will be housed at Norwood Elementary School. We believe this will help our students in their transition to kindergarten.

Since we anticipate more applicants than spaces available, we will be conducting a lottery to determine which students will be attending pre-k in September 2017. If you are interested and have a **child born between December 2, 2012 through December 1, 2013**, please fill out the brief application on the reverse side of this letter, **attach a copy of your child's birth certificate along with two current utility bills** and return the completed application to Jennifer J. Quinn, Ed.D., Deputy Superintendent, at the District Office. The application must be received no later than **Wednesday, May 31, 2017**. The lottery will be conducted on **Thursday, June 15, 2017, at 11:00 a.m.** in the District Office Board Room located at 290 Norwood Avenue, Port Jefferson Station, N.Y. Successful applicants will be contacted and will then have to complete a registration form.

For any interested residents that are not selected at the time of the lottery, you may choose to enroll your child in the SCOPE pre-k program. If you have any questions, please contact Jennifer J. Quinn, Ed.D., at 474-8110.
